Udo not only includes technical and intellectual training for yourself, but also an open eye for society. You should not only try to improve yourself, but also the surrounding society. This means that we should look at shortcomings in society and the needs of the less fortunate and try to improve as much as possible. I am not talking primarily about politics, but about humanitarian and moral commitment as Budo people. And if we do not have open eyes and leave the matter to the so-called public, a lot of injustice can also happen - even in democratic and rule-of-law societies like Japan or Germany.

There have been a number of recent cases in Japan where serious, flawed investigations have been uncovered that resulted in the death penalty for the defendants, and fortunately were later revised prior to enforcement.

Similar cases also occurred in Germany, even if the punishment was "only" life-long. In a murder case, the suspect had been removed from the line of sight of the investigation because it was a police officer. As a result, another person was accused. Fortunately, this person was later completely proven innocent.

Now I would like to describe a specific case from Marburg in detail, which has to do with the current discussion about migration.

An Algerian, by the name of Fatima - adopted after the death of her parents by a Salafist uncle, was to be forcibly married to a much older man than his third wife. But she loved another man named Tarek. Fatima and Tarek decided to flee together. That's why Tarek gave up his successful

workshop. They came to Germany via Spain and France in 2011 - before the big wave of refugees in 2015. They cannot go back to Algeria because Fatima brought great shame on her family in the eyes of their family and uncle. If she were to return, she would be threatened with total social ostracism; but above all, subject to an honor killing. Tarek was reported in absentia for kidnapping and sentenced by Fatima's family. If he were to return, he would be arrested immediately at the airport and would go to prison for about ten years. At first, they tried to gain a foothold here without applying for asylum, but it did not last long. When they subsequently applied for asylum, it was already 2015 and the much criticized "wave of refugees" was a big topic in Germany. As a result - this decision is controversial - the Maghreb countries were declared safe countries of origin, even though Germans have received a partial travel warning to travel to these countries. As a result, the family, which now had two children - the third on the way - was to be deported. Despite legal objections and petitions, this deportation should have taken place in January 2019. At this point, Fatima was in the eighth month of a high-risk pregnancy.

During a night-and-fog operation, the officers woke up the family in their temporary accommodation and even found it necessary to kick the door in. If the Algerian pilot had not had the courage and refused to take off with the pregnant woman on board, this deportation would have been successful, despite the fact that children, as well as pregnant women, are legally worthy of protection in Hesse. However, they could not return to their accommodation afterwards, especially since neighbors took everything that was not tied down, due to the destroyed door.

Here, Dr. Anna Radke, who had previously taught language classes to the refugees, took the entire family, now five, into her 4-room condominium. And they have been living there for a good year now!

How do we know all this exactly? Frau Dr. Radke is now the new tenant of our youngest son, who moved out of the large apartment building in which she also lives. The 79-year-old needs a small place, but it shouldn't be too far from "her" family. Who could blame her for that? When we helped our son move, we learned about all of this. And since then, the fate of these people has moved us.

The commitment of this remarkable woman and that of the local support group is exemplary. That is the wonderfully strong side of German civil society. In my opinion, such people are modern samurai.

But it's not that this is a happy ending. The family is still in danger of being deported. All those involved are now suffering severely from this enormous psychological pressure. The children must be described as traumatized. Just two months ago, a family from Kosovo was deported during the night in the same town of Marburg, although the process was still ongoing to see whether a child in the family was given the right to stay due to severe diabetes, for which insulin is truly needed!

If I did nothing now and if the family of Fatima and Tarek were deported again and handed over to a very dark fate, I would be guilty as a person and especially as a Budo person. Both Susanne and I have already supported the ongoing petition by writing to the Petitions Committee of the Hessian Parliament. Although the support group in Marburg does a lot more for the family, the decision is still open. There are still a few facets to this story, which I do not want to describe in detail here, but would be happy to pass on if requested.

The case of this family is special because it does not involve a war refugee or a political victim. But tolerance for humanitarian reasons seems absolutely necessary to us, if only because of the three children, who are threatened with living a life in social ostracism and with no future prospects in their parents' homeland. The parents even have job offers in Marburg and could immediately take responsibility for themselves if they were given a work permit.

What kind of society do we want to live in? Is it primarily about political calculation and legal regulations? Or is it about people!?

If you would like to find out more and get involved, I provide you a few links below, from which you can see the enormous effort; e.g., Dr. Kurt Bunked who heads the helper circle in Marburg-Coelbe.

Petition Content:

"Fatima Abidi, Gisselberger Str. 2, 35037 Marburg PETITION

In order to protect myself and my family, I ask that you allow us to stay in Germany and that you contribute to the family's livelihood through work.

As I described in detail in my life report (attachment), in 2008 I fled to a Salafist family from a forced marriage with a considerably older man (who already has a wife and children) together with my future husband Tarek Ramdani, whom my family did not consider to be my husband and did not accept him to be my husband. When my family found out about my escape, they filed a kidnapping charge against Tarek Ramdani, which means that if he were deported to Algeria, he would face 15 years in prison. And I would be required to hand over my children (illegal according to Algerian law) to my family, which means certain death for all of us.

My illness/depression (report attached) is a reaction to the years of existential fear and most recently through an attempted deportation in the 8th month of my pregnancy, which was only thwarted because the pilot showed courage and refused to take me, an extremely pregnant woman. Since then, I have been suffering from a flashback of events; and my daughter Mirel, 4, (who is already severely traumatized, certificate attached) has a bed-wetting problem, a typical reaction to traumatization in children.

In addition to this imminent danger to life and limb, I have also moved far away from my home country and have also integrated linguistically into Germany: an adoption by a German, Ms. Dr. Anna Elissa Radke, is almost complete. And I now live with my family in the apartment of these Germans, who took on the mother role for me and the grandmother role for my children. We all speak German to each other. Therefore, I can start an apprenticeship as a hairdresser soon after the birth of my third child (end of March), for which I already have been promised. In addition, I had worked in a hairdressing salon in my home country for many years, but this is not recognized as training in Germany."

Dr. Kurt Bunke wrote the following to the members of the Hessian Parliament:

"Unfortunately, one year after the failed deportation, nothing decisive has changed in any direction. Ms. Radke is still solely responsible for the accommodation of the family at Gisselbergerstrasse 2. Tarek Ramdani still does not have a work permit and is still not allowed to acquire a German driving license. Accommodation costs and work permits are the responsibility of the university town of Marburg, a driving license is the responsibility of the Marburg-Biedenkopf district. However, neither is solely responsible. In the background is the file situation managed by the Central Immigration Office in Giessen with its numerous internal contradictions.

You can find more about this in the two articles cited. If something does not happen soon, the matter will be dealt with through economic, physical, and psychological annihilation of Fatima Abidis, Tarek Ramdanis, and Anna Radkes. I don't just write this. I know what I'm saying. New political initiatives are needed. Lord High Mayor, Dr. Thomas Spies and First District Representative Marian Zachow are of good will. But it seems to me that humanity has overriding limits at the local and state level."

Dr. Kurt Bunke wrote to me:

Dear Mr. Daishiro Nakajima,

I am happy to comply with your request for information, which was sent to me by Ms. Radke. The Petitions Committee of the Hessian state parliament has a petition for Fatima that deserves every possible support. As long as this petition is open, protection against deportation exists. The addressee of your supporting letter would therefore be:

TK TOP1: Reports from the clubs

(critical, worth mentioning, suggestions)

Birgit / Berlin and Munich

The new small group in Berlin (3 people) regularly practices all 3 disciplines.

Bernd / Wiesbaden

Daitoryu was added to the training program along with Aikido and Shinki Toho.

Gunnar / Flensburg

The group started with Shinki Toho training. For the "very northern association," the beginning is difficult, especially when there is no partner with whom you can show the techniques and the distance to other associations with more experienced Shinki Toho practitioners is quite large.

Duncan / Oldenswort

The group regularly practices all three disciplines.

Danijel / Edingen

The group grows slowly but steadily, otherwise no change.

Georg / Heidelberg

The association has several trainers and one training session per week is planned for each. In this situation, it is difficult to practice all three disciplines continuously.

The new hall construction project is still in preparation (gathering the required signatures). The group is currently "tolerated" in the old hall without a rental agreement.

Robert / Düsseldorf

The group consists of approx. 35 people, of which 8–12 practitioners meet regularly. Aikido is practiced primarily.

Marius / Lahnstein

All three disciplines are practiced regularly.

Michael / Uni-Gruppe Karlsruhe

The group separated from a trainer (from another aikido association) because of conflicts with the first exams for new students.

Henry / Dresden

About 8-12 people practice actively. There are fixed times for Shinki Toho and Aikido / Daitoryu.

PK TOP1: discussion about the definition of our style

Starting point: - Soke's comments

The identity of our association culminates in Shinki. It is the task of the examiner commission to embody this center so that the students can experience it. Without this center there is no reason for our association to exist. Therefore, there are two reasons to recommend looking for another association:

- If someone rejects Soke or a member of the commission (trainer), about this central topic from the outset, or shows a consistently closed attitude towards the topic, or
- if someone mainly follows a different style or teacher and only remains a member of the Shinkiryu because of the graduation option.

Daitoryu and Shinki Toho were not added arbitrarily by Soke, but came about in his search for the origin of Aikido. Therefore, it would be ideal if all Shinki members also practice these disciplines. Except for the Dan course, there is hardly any time to talk about all three disciplines. The commissions should, therefore, also like to include Daitoryu and Shinki Toho in the exchange and discussion, although strictly speaking, they were only chosen for Aikido.

Danijel asked if there is anything below the clear focus on Shinki that connects us as a group. Background: At the end of the 90s most courses took place in the Shinki Dojo in Oberkessach. The atmosphere there was perceived as a constant center of strength, which clearly conveys how the training works, how to deal with each other and with which posture you practice. In the current situation - the courses with Soke take place primarily outside Shinki Dojo - this effect of the joint power center is missing. So how do we find the common identity again and again, make sure of it and of the action afterwards?

Duncan noted that the current situation is the natural development of a style, it cannot and should not be turned back. Training at your own location and attending training courses outside - both in combination, ensures exchange and thus development.

Regular training together is a basic requirement for the internal cohesion of the group, in addition to this regular (verbal) exchange. That is why Duncan proposed an annual course,

in which all three representatives of the disciplines Aikido, Daitoryu, and Shinki Toho come together and teach, this offering an important opportunity for finding and developing identity and cohesion.

Henry and Marius cite the following aspects as cornerstones for joint development in Shinkiryu:

- The common examination regulations as a basic framework,
- The initiative of each individual to seek the core of Shinki for themselves in spiritual life,
- The clear identification with the person, Nakajima Soke.

Most presenters found it difficult to narrow down our style beyond these three aspects.

There are several suggestions for maintaining contact with Japan:

- Danjiel gave an idea for discussion: With an increase of the annual contribution by € 5, reserves could be built up over a few years, from which an official trip of one or more representatives could be financed.
- Henry and Bernd offered to spend time on maintaining contacts or to combine this
 with private trips. Duncan says he plans to take care of this contact in three years (after
 retiring).
- Michael suggests an organized group tour for 2025, similar to the trips in 2005 and 2015, but with the provision that the organization then has to be carried mainly by members of the group and not (alone) by Soke.

Regarding the external image or external impact of our association, Danijel suggested offering T-shirts (polo shirts, base caps) printed with our logo throughout the association.

Holger agreed to take on the organizational tasks. He needs support from Jann and / or Johannes for the design / concept. The coordination with the two is still pending.

PK TOP2: Update of the examination regulations

 Adjustment of differences in the Suburi and Kata processes: video and written description do not match in some places..

Michael has worked out proposals to resolve these inconsistencies.

Georg and Michael asked about the comparison of the sword suburi and sword kata with the later added discipline Shinki Toho and their own movements.

Everyone was of the opinion that the question is justified and should be discussed with Soke.

3) Dealing with the requirement jump from the 6th kyu of the children's exams (3 techniques) to the 5th kyu of the adult exams (approx. 30 techniques)

Aspects of the discussion:

- The different belt colors are a great incentive for children.
- The fact that very few children switch to adult groups does not only depend on the "hurdle" of the examination program, but also on other factors such as changing from school to training or study.
- For those who are actually facing a change from a group of children to an adult, an
 individually-adapted, intermediate examination could also be taken by the respective
 trainer with great sensitivity.

A decision was postponed.

Michael will work out a written proposal to adapt the 6th Kyu exam.

PK TOP3: elections and election modalities

Soke advocates a small number of commissioners with a clearer assignment of tasks. The coaching commission is a requirement of the Aikikai. From Soke's point of view, it would be better if all trainers sat together and discussed, when time allowed.

The suggestion to combine the right to vote with the proof of attended courses is described by Duncan as organizationally very complex and possibly not practical.

A differentiation of the electoral modalities for the examiner and the trainer commission is generally considered useful:

The examiner commission as a commission should be determined by experts. The right to vote from 1st Dan onwards is appropriate here.

The coaching commission, as the representative of the individual local groups, should be broader and should also be able to be elected by a wider group. It would be conceivable to set the eligibility to vote at a certain kyu level.

Duncan subsequently discussed with Svenja Clausen that she would take care of the online implementation of the choice. She will learn about the technical possibilities. The election will take place at the end of September 2020.

The subject requires further coordination with Soke.

PK TOP4: Creation of a video for the techniques of the 4th Dan, Okuden recordings of the Shinki Toho

Soke's basic stance:

The videos are only to be viewed as a reminder. Each technique should first be experienced and practiced directly in training. Then you can use the video to remember.

Soke subsequently announced the following:

The video recording for Shinki-Toho-Okuden has already been completed. It will be finished soon. The recording for Aikido-4.-Dan will also be completed soon. The type of reference is still being clarified.

PK TOP5: Proposal for an annual course that is held by the respective representatives of the individual directions

(Daitoryu: Danijel, Shinki Toho: Helmut, Aikido: Duncan)

The proposal is welcomed. Danijel and Helmut agree. The appointment and coordination of the venue is still pending. Duncan will take over the coordination.

Supplement: Miscellaneous, Examination courses 2020

For 2020, the following courses have been defined as Dan exam courses:

- Edingen 22./23. February 2020
- Munich 04/05/05 July 2020
- Dresden 07./08. November 2020

The next Dan level course in Edingen is scheduled for 6 -7 February 2021 - Soke subsequently agreed to this date.
